Dear Ms. Kiefel:

I am writing this letter as a follow up to an earlier letter submitted in response to the U.S. Army Corps of Engineers request for proposals in accordance with Section 7001 of the Water Resources Reform and Development Act of 2014 (WRRDA 2014).

The Okeechobee Utility Authority (OUA) has conducted extensive design and research concerning the construction of a vacuum collection system for the Treasure Island area shown in Attachment A – Treasure Island Service Area. Area surveys, environmental impact studies, wetland assessments and preliminary design layouts are a few of the necessary work items conducted to date.

As shown in the attachment, much of the area is waterfront property due to the significant number navigable waterways. Due to many factors including nutrients, grasses, plants and other vegetative matter (both submerged and emergent) become hazards to navigation.

Attachment A depicts an early conceptual design incorporating the vacuum sewer divided up into a northern and southern district. Each district (see Attachment C) will have a collection system and pump station. The collected wastewater will be pumped to a regional wastewater treatment facility where the water will be treated and disposed of through a permitted effluent disposal facility.

The Treasure Island area is an older established community here in the Okeechobee area. The residences are small and generally owned by retirees or available as rental property to young families. As noted in Attachment B, Okeechobee County in general has an average per capita taxable value of \$39,540, which is just over 57% of the statewide value. Treasure Island values are lower than the overall Okeechobee County average.







**Attachment B – Okeechobee County Average Taxable Property Values**




Treasure Island North Vacuum Sewer

Dear Mr. Clay:

The South Florida Water Management District (SFWMD) understands that the Okeechobee Utility Authority (OUA) is seeking a grant under the Water Resources Reform and Development Act (WRRDA) 2014 for the Treasure Island Vacuum Sewer System and East Side Force Main Project. The SFWMD is submitting this letter to indicate that the proposed septic to sewer project is included in the Lake Okeechobee Watershed Protection Plan and it supports the goals of the Northern Everglades and Estuaries Protection Program.

The Watershed Protection Plans associated with the Northern Everglades and Estuaries Protection Program (373.4595 Florida Statutes) identified failing septic tanks as a contributor to degraded water quality and includes septic to sewer conversion projects as measures to improve water quality. The Okeechobee Utility Authority Treasure Island Vacuum Sewer System and East Side Force Main Project, to remove the dependency of septic systems in this area, was included as a specific management measure in the 2014 update to the Lake Okeechobee Watershed Protection Plan to help improve the quality of water entering Lake Okeechobee. The Treasure Island development is located in the Taylor Creek Nubbin Slough Sub-watershed which drains to Lake Okeechobee and is a priority area for water quality improvements due to elevated levels of nutrients.

I am pleased to provide this letter in support of the Okeechobee Utility Authority's efforts to obtain a federal grant. The goal of their proposed project to conduct a feasibility study and to protect the Lake Okeechobee/Everglades Ecosystems. I respectfully request your consideration of this organization's application for federal funding.

The Okeechobee Utility Authority would act as the non-Federal sponsor for this project, providing for the removal of approximately 1,600 septic tanks and associated drain fields and several small wastewater package treatment plants which impact both environmental and aquatic ecosystems. The Economic Council of Okeechobee supports the efforts of the Okeechobee Utility Authority to complete the Lake Okeechobee/Everglades Ecosystem Protection Project contingent upon the availability of grant funding to cover the total costs of the project.

Our economically-disadvantaged community has already contributed significant funds to this project and our designation as a Rural Area of Critical Economic Concern necessitates Federal funding to complete the construction of the project.


