The Baptiste Collette waterway is situated on the east bank of the Mississippi River across from the Venice Port facilities. Transportation cost savings are expected for mid size vessels by providing shorter access to the eastern Gulf of Mexico in lieu of transiting via Southwest Pass. Also anticipated is improved safety for these midsize vessels who currently share the super highway that is the Mississippi River Ship Channel. By getting off the main “highway” onto a safer side channel that is absent the massive, international ocean vessels, risks to safety are expected to decrease. It should be noted that these safety issues are not quantified in the economic justification, but are still a serious concern for the navigation industry.
